we wish to inform you that the EU Reg. 679/2016 (and the Legislative Decree 196/2003 and subsequent amendments, only as far as it complies with the EU Reg. 679/2016) provides for the protection of individuals with regard to the processing of personal data. ### **The purposes of the processing for which the personal data are intended as well as the legal basis of the processing;**

The purpose of the processing is as follows:

We inform You that for the aforementioned purpose, Your personal data will be processed (personal data, contact data such as, for example, email addresses, telephone numbers/etc ...).

It should be noted that, in no section of the site, nor for access to any functionality of the site, is the provision of "particular categories of personal data" and/or "personal data relating to criminal convictions and offenses", as defined from art. 9 and 10 of EU Reg. 679/2016: if the User spontaneously sends information of the aforementioned type to the data controller, the data controller will delete them as they are not strictly necessary for the aforementioned purpose.

The legal basis of the processing is related to the provisions of art. 6 paragraph 1 letter a) of EU Reg. 679/2016, as the interested party has given consent to the processing of their personal data for one or

more specific purposes.

**If the processing is based on article 6, paragraph 1, letter f), the legitimate interests pursued by the data controller or by third parties;**

We inform You that the data processing is not based on article 6, paragraph 1, letter f), as the processing is not necessary for the pursuit of the legitimate interest of the data controller or third parties, provided that the interests do not prevail the fundamental rights and freedoms of the data subject that require the protection of personal data, in particular if the data subject is a minor.

**Any recipients or any categories of recipients of the personal data;**

Your personal data will be processed by people specifically appointed by the data controller as data processors (if appointed) and/or by anyone acting under their authority and/or under that of the data controller and who has access to personal data (Administrators/shareholders/workers of the data controller); these subjects will process your data only if necessary in relation to the purposes of the provision and only in the context of carrying out the tasks assigned to them by the data controller, undertaking to process only the data necessary for the performance of these tasks and to carry out only the operations necessary to carry out the same.

Your personal data will not be communicated to third parties and/or disclosure.

**Where applicable, the intention of the data controller to transfer personal data to a third country or to an international organization and the existence or absence of an adequacy decision by the Commission or, in the case of the transfers referred to in Article 46 or 47, or in Article 49, second paragraph, the reference to the appropriate or opportune guarantees and the means to obtain a copy of such data or the place where it was made available.**

We also inform You that personal data may be subject to intercompany communication between the companies of the Group. The data may be disseminated or transferred to non-EU countries.

It should be noted that the personal data relating to the aforementioned processing are managed in hosting on a server located in Italy.

In addition to the information previously provided, the data controller provides You with the following additional information necessary to ensure correct and transparent processing:

**The retention period of the personal data or, if this is not possible, the criteria used to determine this period;**

Your data will be kept for the time necessary to achieve the purposes indicated above. The data will be kept for the time strictly necessary to respond to requests from the contact forms on the company website and, at most, for a period of 5 years from the time of collection.

**The existence of the right of the interested party to ask the data controller for access to personal data and the correction or cancellation of the same or the limitation of the processing that concern him or to oppose their treatment, in addition to the right to data portability;**

You may, at any time, exercise the following rights towards the data controller under EU Reg. 679/2016, by contacting the data controller at the addresses indicated in point a) of this information:

Right of access by the interested party (Article 15 of EU Reg. 679/2016).

Right of rectification (Article 16 of EU Reg. 679/2016).

Right to cancellation - "right to be forgotten" (Article 17 of EU Reg. 679/2016).

Right to limitation of processing (Article 18 of EU Reg. 679/2016).

Right to object (Article 21 of EU Reg. 679/2016).

Right to data portability (Article 20 of EU Reg. 679/2016).

**If the processing is based on article 6, paragraph 1, letter a), or on article 9, paragraph 2, letter a), the existence of the right to withdraw consent at any time without prejudice to the lawfulness of the processing based on consent given before revocation;**

You may exercise the right to withdraw the consent towards the data controller at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation.

**The right to lodge a complaint with a supervisory authority;**

If You believe that the processing that concerns You violates this regulation, You have the right to lodge a complaint with a supervisory authority (Article 77 of EU Reg. 679/2016).

**If the communication of personal data is a legal or contractual obligation or a necessary requirement for the conclusion of a contract, and if the interested party is obliged to provide personal data as well as the possible consequences of failure to communicate such data;**

The data communications described above are necessary to process Your contact request and are strictly connected to normal company operations; therefore, failure to communicate could make it impossible to process Your contact request (in particular, as regards the "mandatory fields", present in the information collection form).

**The existence of an automated decision-making process, including the profiling referred to in Article 22, paragraphs 1 and 4, and, at least in such cases, significant information on the logic used, as well as the importance and expected consequences of such processing for the interested.**

The data controller informs You that Your data will not be subject to an automated decision-making process, including the profiling referred to in Article 22, paragraphs 1 and 4 of EU Reg. 679/2016.
